On the basis of the results declared for the B.Ed., Entrance Test held on 27th July, 2019, you have been **provisionally** selected for attending the B.Ed., admission counselling. Confirmation of admission is subject to fulfilling the eligibility, verification of all original documents with attested copies of certificates and resolving tie-up cases, if any, in each category.

Eligibility: Candidates with:

a) At least fifty percent marks either in the Bachelor's Degree and / or in the Master's Degree in Sciences / Social Sciences / Commerce / Humanity. Bachelor's in Engineering or Technology with specialization in Science and Mathematics with 55% marks or any other qualification equivalent thereto,

and

- b) The following categories are eligible to be students of B.Ed. (ODL):
 - (i) Trained in-service teachers in elementary education
 - (ii) Candidates who have completed a NCTE recognized teacher education programme through face-to-face mode.

The reservation and relaxation of 5% marks in minimum eligibility will be provided to SC / ST / OBC (Non Creamy Layer) / PWD candidates as per the rules of the Central Government.

- Degrees acquired from an 'Off Campus' Centre of Private Universities outside the territorial
 jurisdiction of the concerned State is not recognized for the purposes of admission to IGNOU's
 academic programmes unless it has specific approval of the University Grants Commission.
 Similarly, Degrees acquired from an 'Off Campus' Centre/ 'Off-shore' Campus of Central/State/
 Deemed to be Universities/Institutions of National Importance offered through Distance mode of
 learning will be accepted for higher studies in IGNOU; provided these have been obtained as per
 territorial jurisdiction of these Central/State/Deemed to be Universities/Institutions of National
 Importance prescribed by the University Grants Commission from time to time.
- Students who have pursued UG or PG Degree through Distance Mode are advised to bring the College ID Card / Examination ID card / any other proof which establishes the place of study and name of the College to verify the territorial jurisdiction of the study.
- Simultaneously pursuing two academic Programmes either from the same University, or one from the Open University (under ODL mode) and the other from Conventional University (regular or faceto-face mode) is not permitted, as of now, except Certificate Programmes of six month duration. Those candidates who acquired the Master's Degree without the Bachelor Degree are not eligible for Admission to IGNOU's B.Ed. Programme.

According to your Rank/Marks position, you have been called for the admission counseling, <u>provisionally</u>, under SC / ST / PH / OBC (NCL) / War Widow /General and Economically Weaker Sections (EWS) category. In respect of candidates belonging to <u>OBC(NCL)</u> only the <u>Central List</u> will be followed. The Annual income of the candidates under <u>OBC (Non Creamy Layer)</u> should not exceed 8.00 lakhs per annum.

Reservation under EWS Category: Eligible students need to submit the Certificate (in the prescribed format) issued by not below the rank of Thehsildar in the States / UTs in respect of income and assets of the families of the applicant claiming reservation under EWS quota. The provision of reservations to the Economically Weaker Sections shall be in accordance with the directions contained in the O.M. No. 20013/01/2018-BC-II dated 17th January, 2019 of the Ministry of Social Justice & Empowerment, GOI, without affecting the percentage reservation of SC/ST/OBC/General.

Mere receipt of this communication inviting you to attend B.Ed., Counselling, will not confer any right for admission provided you fulfill all the eligibility prescribed. Therefore, the candidates are advised to check their eligibility for admission to the B.Ed., Programme, before attending the admission counseling.

B.Ed., admission counselling will be held at IGNOU Regional Centre, Sikkandar Chavadi, Alanganallur Road, Madurai-625 018 on 29th November, 2019 at 10.00 a.m.

If you are not present on the date & time of counselling, it will be presumed that you are NOT interested in accepting the offer/joining IGNOU B.Ed., and hence this letter is sent to you will be **cancelled without further notice.** Madurai Regional Centre will be functioning as Nodal Regional Centre (RC) for conducting B.Ed., admission counselling for six Regional Centres. Only one Programme Study Centre, comprising maximum of 55 (50 + 5 (EWS))Seats, is available for the meritorious candidates, appeared for B.Ed., Entrance Test, from the six Regional Centres viz., Port Blair, Chennai, Cochin, Madurai, Trivandrum and Vatakara.

<u>BEd., Programme Study Centre</u>: Sri Ramakrishna Mission Vidyalaya College of Education, Coimbatore 641 020 (PSC 2516P) will be the Programme Study Centre.

<u>Programme Fee</u>: You should bring the Programme Fee of Rs.50,000/- (Rupees fifty thousand only) in the form of a Demand Draft drawn in favour of "IGNOU" payable at Madurai from any one of the Nationalized Banks.

You must bring ALL THE DOCUMENTS IN ORIGINAL as well as one set of attested copies of documents as listed in Annexure I along with the CHECK LIST for verification. In case you fail to bring the documents and fail to provide required evidences for qualifications and category / community / caste certificates, etc., your candidature will be summarily rejected.

Candidates should bring a certificate, issued by the institution where the candidate has pursued his/her Teacher Education Programme stating that the institution is recognized for offering the Programme, through face to face mode, by NCTE, along with a copy of the recognition letter issued by the NCTE to that institution. In case the recognition letter is not available, than a certificate issued by the institution should contain the details of the letter no. and date of issue of recognition/approval for offering the Teacher Education Programme through face to face mode by the NCTE.

Permission for practical work (work centre) including Internship should be obtained only from Upper Primary / Secondary / Higher /Senior Secondary School (Annexure 4A). The certificate obtained from Primary / Nursery School are not accepted.

The candidates falling under "Tie" category should bring all the graduation and / or PG Certificates and mark lists to resolve the tie-up cases. Admission of candidates invited for B.Ed., admission counselling under "Tie" is subject to resolving the tie-up cases in each category.

Resolving Tie Cases:

In respect of the candidate scoring same marks / rank, the tie will be resolved as under:-

- a) Qualification: The overall score secured by the candidate in qualifying examination at post graduate level and then at graduate level will be considered in following order:
 - i). Two marks will be given for post graduation with 50% marks.

ii). One mark will be given for graduation with 50% marks.

- iii). If still there is a tie-up, then preference should be given to higher percentage of marks in **graduation level**
- b) Age: If tie up still exists, then date of birth of the candidate in the descending order i.e. the candidates born earlier will be ranked higher than the one born later.

"This offer of admission is provisional and is based on the documents in respect of qualification and other eligible criteria submitted by you along with the application form. If at a later stage, it is found that the document(s) submitted by you is/are false, your admission shall stand cancelled forthwith and no fee refund will be admissible in the event of such cancellation of admission."


